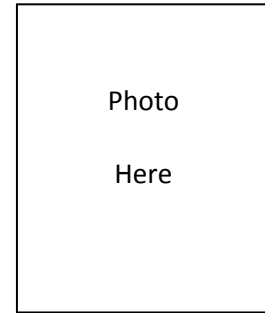

## STATEMENT OF TERMS

"We, the undersigned, understand that the educational program is an integral part of the church ministry which I support.

"We hereby commit to assume financial responsibility to Good News Christian Academy. We understand that we are responsible for the payment of all fees, including application, administration, and curriculum that may be incurred during the time this student is enrolled in Good News Christian Academy (GNCA). We have reviewed this application and, to the best of our knowledge, all information provided is complete and accurate. We understand that a school year is considered to be a maximum of nine months, beginning on the date enrollment is completed and ending either nine months later or when the student has completed all curriculum assigned (maximum 72 PACEs) for the school year, whichever comes first.

“In order for enrollment to be processed, we understand that all Registration and first Tuition Fees must accompany this completed application. We understand that the Registration Fee is nonrefundable and is to be paid prior to the beginning of the school year. We understand that the Tuition Fee is non-refundable on a monthly basis and is expected to be paid prior to the beginning of the school year for the first month, and at the beginning of each subsequent month. We understand that the Tuition Fee is considered late after the 10<sup>th</sup> of the month and an additional fee of \$10.00 will be assessed for each late payment. We understand that statements with outstanding balances are due within 30 days. We understand that all fees and charges must be paid in full prior to any transcripts, verification forms, or diplomas being provided.

“We understand that enrollment in GNCA is a privilege, and GNCA reserves the right to suspend or expel any student in accordance with its official policies as determined by GNCA. Notwithstanding anything to the contrary contained herein, this agreement does not bind either party to any specific period of enrollment. We understand that no rights or presumptions of continued enrollment are conferred or implied by this agreement. We further agree that no right to notice of renewal or nonrenewal of the agreement is conferred or implied. We understand that acceptance of the application shall be conditioned upon completion of all requirements to the satisfaction of the administration.

“We understand that our child is expected to take part in school educational activities, including sports and sponsored trips away from the school campus, and we absolve the school from liability to us or our child because of any injury to our child at supervised school activities.

“We agree to uphold and support the high academic standards of Good News Christian Academy by providing a place at home for our child to study and by encouraging our child in the completion of any homework or assignments.

“In regard to profanity, obscenity in word or action, dishonor to the Godhead or the Word of God or disrespect to the staff of the church and school, we hereby agree to support regulations published in the GNCA Handbook in the applicant’s behalf and authorize Good News Christian Academy to employ discipline as it deems wise and expedient for the training of our child.
